Call to Order / Introductions

Meeting attendees introduced themselves and the agencies they represent.

RTTAC and the TSM&O Subcommittee Overview

Mark Plass (Broward MPO) and Hector DiDonato (Miami-Dade TPO) introduced themselves as the new chair and vice chairs of the Regional Transportation Technical Advisory Committee (RTTAC) Transportation Systems Management & Operations (TSM&O) subcommittee.

The dates for the 2024 in person quarterly meetings will be last Thursday of January, April, July, and October. The meetings will be at the Broward MPO office on January 25th, April 25th, July 25th, and October 24th, 2024.

The subcommittee's purpose is to provide input in the RTTAC travel demand model in particular for TSM&O. This group also shares lessons learned and initiatives in the Miami-Dade, Broward, and Palm Beach counties. In the past, this group created educational and outreach material to share with the public.

Mark asked the group about topics of interest for discussions and presentations. The attendees listed: active arterial management, grant opportunities, smart work zones,

resiliency as it relates to TSM&O, and innovative projects including artificial intelligence (AI) projects.

Mark would like to share with the group TRB articles for discussion. TRB standing technical committees need abstract reviewers every year. All that is needed is to sign-up as a Friend of a committee to receive correspondence and to begin participating.

The plan of topics for the next 2 years will include TSM&O regional corridor strategies, grants opportunities as a region, workforce development opportunities including attending high school and technical schools.

Opportunities to Collaborate

- The 2050 Regional Regional Transportation Plan Update will be presented at another meeting about updates. The group would like to look into opportunities to collaborate towards regional mobility strategies and recommendations.
- FDOT D4 will be doing a master plan update
- Broward MPO is working on a digital twin application. Mark is in the process of finding and vendor and will share with the group at a later meeting. This tool can leverage planning based on different model outcomes.
- FDOT D4 would like to see Tri-rail stations incorporated into travel demand models
